I expressly acknowledge and agree to be bound by the principle that "under Missouri law, an equine professional is not liable for any injury to or the death of a participant in equine activities resulting from the inherent risks of equine activities pursuant to the Revised Statutes of Missouri." I further expressly waive all claims against the management of this Competition, including but not limited to the organizers of this event, The Lake St. Louis Exposition Park, LLC dba The National Equestrian Center, and Queenie Productions, LLC, for any and all accident, loss and serious bodily injury, including broken bones, head injuries, trauma, pain, suffering or death. I further expressly assume all risks of harm to me or my horse, including harm resulting from negligence of the Competition management, The National Equestrian Center, and Queenie Productions, LLC.
